Pet Care Agreement and Liability Information

This is an Agreement between Lago Vista Pets (LagoVistaPets.Com) and the pet owner/ client whose signature appears below (hereinafter referred to as "I," "me" or "my").

*Please acknowledge the following policy statements by initialing the space provided and signing at the bottom of the page.

___ For myself, my heirs and any assigns, I hereby release Lago Vista Pets, its agents, officers, employees, animal owners, customers and potential customers of Lago Vista Pets from any and all liabilities, financial or otherwise, for injuries to myself, my dogs, or any other property of mine which arise in any way from our services and/or products provided by or as a consequence of my association with Lago Vista Pets, in the absence of gross negligence.

___ In consideration of the services rendered to the Guest or Client by Lago Vista Pets, the Guest/Client waives any and all claims, actions or demands of any nature, foreseen or unforeseen and he/she may have now, or in the future against Lago Vista Pets relating to the care, control, health, and/or safety of the Guest or Client arising during transport, drop-off, and stay at the facilities at which the Guest is being cared for.

___ I understand that Lago Vista Pets expects Clients to bring their pet(s) for a temperament evaluation prior to boarding. Lago Vista Pets will give me an honest opinion of how my dog fared overall, whether they saw signs of stress, aggression or other problematic behavior, and will advise whether or not Lago Vista Pets is a good fit for my dog. Lago Vista Pets solely will make the determination whether its services are suitable for my dog.

___ I understand my dog will have close contact with other dogs during group play. I understand that the owners and staff at Lago Vista Pets will not knowingly admit into the area dogs that are obviously aggressive in nature. I am also aware that disagreements can occur when guests become overzealous, however due to the benefits of dog socialization, I waive the risk. Therefore, I personally request a socialized environment for my pet while under the care of Lago Vista Pets.

___ I agree to assume all liabilities and responsibilities, financial or otherwise, for the behavior and health of my pet. I agree to hold Lago Vista Pets harmless from any claims, actions, or demands against Lago Vista Pets arising during the stay at Lago Vista Pets in the absence of gross negligence.

___ I authorize Lago Vista Pets to do whatever they deem necessary for the safety, health, and or well being of my dog while under the care of Lago Vista Pets. In the event of a medical problem I would like for my dog:

___ to be taken to my regular veterinarian for care. By choosing this agreement I understand I am responsible for all charges incurred.

___ to be taken to a veterinarian that Lago Vista Pets deems appropriate should my vet be unavailable.

___ In the event of an after - hours emergency, I would like my dog to be taken to an emergency facility for care. By choosing this option I understand that I am responsible for all charges incurred.

___ I agree to pay the rates for pet care provided and for additional services requested, if any, in effect on the date my pet(s) is/are checked into Lago Vista Pets as guest(s). I further agree that all charges shall be due and payable upon the departure of the pet(s) and that the pet(s) shall not leave Lago Vista Pets until all charges have been paid in full.

___ To the best of my knowledge, my pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in.

___ Pets are required to be on flea prevention during the summer months. Pets arriving with fleas or ticks will be bathed and treated at the discretion of Lago Vista Pets staff, at my expense.
